ARTICLE IX SPECIAL PROVISIONS RELATING TO SUNNYLANDS

9.1 Generally.

In the event it is acquired by the Trust, the approximately 200 developed acres of property known as "Sunnylands," located in Rancho Mirage, California, shall be permanently utilized by the Board of Trustees directly, exclusively and solely for charitable, scientific, literary or educational exempt purposes enumerated under Sections 170(c)(2)(B) and 501(c)(3) of the Internal Revenue Code and the funds held under this Trust shall be used to maintain Sunnylands in support of and in furtherance of such exempt purposes.

9.2 Permitted Programs.

If acquired by the Trust, the Board of Trustees shall, at all times and under all circumstances, use Sunnylands directly, exclusively and solely to implement, carry out and further a broad range of permitted programs ("Permitted Programs"), designed to further the Trust's exempt purposes under Sections 170(c)(2)(B) and 501(c)(3) of the Internal Revenue Code. The Permitted Programs hereunder shall be limited, at all times and under all circumstances, to making Sunnylands available for the following purposes:

- a. For the President of the United States and the Secretary of State of the United States to bring together world leaders in order to promote world peace and facilitate international agreement.
- b. For (i) the President of the United States and the Cabinet. (ii) The United States Supreme Court, (iii) the leadership of the United States House of Representatives of both the Republican and Democratic parties, and (iv) the leadership of the United States Senate of both the Republican and Democratic parties, respectively, to meet in order to focus on ways to

improve the functioning of the three branches of government or other important issues facing these governmental bodies.

c. For leaders of major social institutions, such as universities, colleges, public schools, charities, governmental agencies and other important public bodies to meet in order to address and determine how these institutions could better serve the public and the public good.

Interesting word choice: to "Conduct programs" =/= meet to discuss

d. For the schools and other charitable or educational institutions created or funded by The Annenberg Foundation, such as, by way of example, the Annenberg School for Communication at the University of Pennsylvania, the Annenberg School for Communication at the University of Southern California, the Annenberg Public Policy Center, the Annenberg/CPB Project, and the Annenberg Institute for School Reform at Brown University, to conduct programs focusing on the advancement of important educational and social issues.

e. To host (i) programs of learned societies, i.e., bodies of distinguished

and as reported persons, in the humanities and social sciences, (ii) meetings of leaders and distinguished elsewhere in Annenberg biographies and in the Press, there was an intention for Sunnylands to become "Camp David West. practitioners in education, philanthropy, the arts, and culture, and (iii) meetings of leaders and

specialists in the major medical and scientific associations and institutions, respectively, for the purpose of promoting and facilitating the exchange of ideas among leaders in the foregoing fields of endeavor and in public affairs and public life, so as to provide the widest possible range of opportunities for high-level interaction and communication for the advancement of such fields of endeavor for the common good and the public interest.

f. For The Annenberg Foundation to conduct meetings for the purpose of formulating policies and programs to further its charitable and other tax-exempt purposes.

You can also see elements of its goal being the Californian "Wingspread Conference Center" (a la Johnson Family wealth, Racine Wisconsin, whose conferences in 1999 and earlier (and since) deeply influence the domestic violence/family court systems

The one thing these Annenbergs (plural) do NOT seem to have subscribed to is our forms of: representative government (separation of powers), accountability of government to the people (as also seen in their choice of where to form different schools of communication), the California Brown Act (open meeting policies) and in general balance of powers. It's unbelievably arrogant! Combined with sponsoring Ted Sizer's badly-behaving Coalition for Essential Schools, Inc. at the AISR, irresponsible.

g. For public access, on an objective and nondiscriminatory basis, to educate the public on the educational and historical significance of Sunnylands.

9.3 <u>Duties of Trustees</u>.

- a. The Board of Trustees of the Trust may use Sunnylands for the purpose of holding meetings pursuant to Article 3.1.
- b. The Trustees of the Trust shall have reasonable access to Sunnylands in order to carry out and perform their duties in furtherance of the Trust's charitable, scientific, literary or educational exempt purposes of Sections 170(c)(2)(B) and 501(c)(3) of the Internal Revenue Code, including in connection with the planning, implementation and oversight of Permitted Programs, as defined in Article 9.2.

9.4 Library/Museum/Conference Center.

If the Trust builds the Center, as defined under Article 4.5, on the currently unimproved portion of the property at Sunnylands, the Center shall be permanently utilized by the Board of Trustees directly, exclusively and solely for charitable, scientific, literary or educational exempt purposes enumerated under Sections 170(c)(2)(B) and 501(c)(3) of the Internal Revenue Code and the funds held under this Trust shall be used to maintain the Center in support of and in furtherance of such exempt purposes.

9.5 Fundraising.

The Board of Trustees of the Trust may utilize the Center (if built) for fundraising purposes, but not the Two Hundred (200) acres known as Sunnylands, and may otherwise engage in other fundraising programs, with any proceeds therefrom to be applied to the general and administrative costs of operating Sunnylands and the Trust's Permitted Programs.

ARTICLE X DECLARATION OF TRUST

All of the actions of the Trustees are subject to the terms and conditions of the Declaration of Trust. Nothing herein is intended to supersede, conflict or be inconsistent with any provision set forth under the Declaration of Trust and, under all events, the terms and conditions set forth under the Declaration of Trust shall control and override any provision in these Bylaws that may otherwise be considered to supersede, conflict or be inconsistent with any provision of the Declaration of Trust.

ARTICLE XI AMENDMENTS

These Bylaws may be amended or repealed and new Bylaws may be adopted by the Board of Trustees in accordance with the voting requirements under Article II of these Bylaws. Any amendment to these Bylaws must be in conformity and consistent with the Declaration of Trust.
