Looks like complying with annual rept filing for this HHS-supported entity with (at last look, now \$27M Gross assets) is a REAL low priority.**

Blogger ("Let's Get Honest" at FamilyCourtMatters.org, since From separate (Form 990) database search, and it being divulged (if one looks HARD for it) on the website "TheNationalCouncil.org" (which website namechange predates, apparently organization name change from earlier "National Community Council for Behavioral Healthcare Management" and earlier website: NCCBH.org), I know the EIN# is 23-7092671. These tax returns show a major increase in revenues around the time it began filing more regularly. The org. has, however, been growing steadily year after year at least in the 21st century — yet below, it wasn't filing its annual or bi-annual reports with the government of D.C.
