## ARTICLES OF INCORPORATION FOR A TAX-EXEMPT NONSTOCK CORPORATION

**FIRST:** The undersigned Ruby Norris Freeman, Lisa Nitsch, Nisa Muhammad, and Linda Aitch whose address is 22 Sunrise Court Randallstown, Md. 21133 being at least eighteen years of age, do hereby form a corporation under the laws of the State of Maryland.

**SECOND:** The name of the corporation is Women in Fatherhood, Inc. H

**THIRD:** The purposes for which the corporation is formed are as follows: Our purpose is to support positive father involvement and healthy family relationships. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**FOURTH:** The street address of the principal office of the corporation in Maryland is 22 Sunrise Court Randallstown, Md. 21133

**FIFTH:** The name of the resident agent of the corporation in Maryland is Julia Hayman Hamilton whose address is 22 Sunrise Court Randallstown, Md. 21133.

**SIXTH:** The corporation has no authority to issue capital stock.

**SEVENTH:** The number of directors of the corporation shall be four which number may be increased or decreased pursuant to the bylaws of the corporation. The name(s) of the director(s) who shall act until the first meeting are Ruby Norris Freeman, Linda Nitsch, Nisa Muhammad and Linda Aitch until their successors are duly chosen.

**EIGHTH:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, All of its assets and net income, current and accumulated, remaining after the payment of its debts, obligations and claims shall be transferred to and become the property of the Center for Fathers, Families and Workforce Development, a nonprofit corporation exempt from the Federal Income Tax under section 501 c3 of the Internal Revenue Code of 1954. Any such assetd not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
