


Carolyn D. Meadows


Bob Beauprez

He frequently testifies before Congress and is featured in many top tier television, radio, and

online media. Dr. Jasser is a former U.S. Navy Lieutenant Commander with 11 years of service, including a tour as the Staff Internist to the U.S. Congress and the U.S. Supreme Court. His parents fled the oppressive Ba'ath regime of Syria in the mid-1960s for American freedom. He and his family have strong ties to the American Muslim community, having helped lead mosques in Wisconsin, Arkansas, Virginia and Arizona. He is currently a physician in private practice. Dr. Jasser and his wife and three children live in Scottsdale, Arizona.
