****What I went and am going through**** personally. This isn't worth footnoting to the bottom of the post, nor do I want it there so close to the "tags" and comments sections, so I'm including here it in very small print to qualify the statement: I have obviously access to a computer, am fed and clothed well enough to speak in complete sentences, but there have been some things... they have been going on for years and they are not over yet. ^{Where} the energy, means, or resources to where I am actually free (back to close to a normal state of existence ^{certain} ~~without~~ "coercive control" of a different sort in the hands of people or their successors who have ALREADY put me systemically homeless and living week-to-week at their mercy, or lack of it, and sense of professional responsibility or (case in point) lack of it.

Having cut off ALL exposure to the means and levels of ongoing

I'm still looking to summon, muster, access or otherwise establish conditions to acquire THROUGH WORK

(As have mentioned a few times on the blog in 2019, in summer 2018 I fled the State of California with only what would fit in a car, for my own safety as a senior, after having been forced to live in hotels for nearly three years, draining resources (others controlled); I am in a better place now, but still dealing with the consequences; the complete break with those in California is not complete, or financial independence for basic life expense yet replaced; more litigation-- I did not participate this time -- of course littered the road). On leaving I had one temporary destination only and did not know in what state I would end up. I've managed to sign and so far maintain a lease, make some new friends, and even (expensively) rescue substantial belongings from storage (including one capital asset which supports work), **but** I never had credit after the #DV (it was stripped off by the abuser under threat and never regained; HE used MY work while married to obtain credit (not shared) for himself. **I do not have either credit or full-time (or otherwise fully adequate) work yet, and while known to be seeking it, was slapped with another lawsuit back in California changing (worsening) the dynamics significantly.** This impacts housing; as does not having a stable work history after exiting abuse and even after the family court gauntlet essentially dropped off when our children became adults and I do not even know WHERE their father, my ex is, currently (and hopefully, vice versa, which is good). At all times, speed of transition to full independence is key. Right now, the recent litigation (which I did not participate in and am not describing specifically here except to say no criminal charges are involved, and that I am not and never have, to my awareness, been ruled a "dependent adult" in the classic sense nor am I physically or mentally disabled or a substance abuser) has slowed it down and puts it in jeopardy. I have less than one month's reserve in my possession, and do not know where the following months may come from, or what conditions (the one I'm most concerned about is forfeiting privacy of location) would be required to receive or EARN resources enough to pay basic bills. or time zone, other than a distant one,

WE ARE TO RETAIN A CHILDLIKE SIMPLICITY AND TRUST AUTHORITIES -- EXCEPT WHEN IT COMES, OF COURSE, TO OUR WORK LIVES, WHERE WE ARE TO BE DILIGENT, DEDICATED, AND PRODUCTIVE. AS CHILDLIKE ADULTS, IT'S BEEN DEEMED THAT WE CAN BE TOLD ENDLESS "STORIES" ABOUT REALITY.
